Every PMI Product goes through stringent testing protocols and is inspected before it leaves our factories to make sure that it is safe and healthy to use for both food and drink. We also comply with all global regulations and where appropriate we adhere to all ASTM standards for products to be used by children.

Our dedicated Quality team works closely with our factories, third party labs and our clients to insure the best level of compliance for our products. We engage our entire supply chain in the assurance of the quality, safety and compliance of our products.

 - All PMI products comply with REACH requirements, and do not contain the substances listed on the Substances of Very High Concern (SVHC) list released by the European Chemicals Agency (ECHA) Including EU 2017/752
 - PMI keeps on file third party lab test reports for all PMI products.
 - Every product is rigorously tested to make sure it is safe and healthy for adults and as appropriate for children.
 - PMI adheres to CA Prop 65 requirements for food contact surfaces, exterior coatings, logos and decorative treatment.
 - We have a dedicated team that works onsite and with testing facilities to make sure that we meet or exceed global health and safety regulations.
 - We set our internal guidelines to protect our vendors, customers and our consumers.
